## Main objectives of the project

Main objective of this new capacity**building project** is furthering the quality of doctoral education at partner Higher Education Institutions in Uzbekistan and to provide quality assurance measures and mechanisms for Uzbek partners, in line with the principles of doctoral training in Europe and the results achieved through the UZDOC project.





### Specific objectives

- To improve the capacity of Uzbekistan HEIs for supporting doctoral education, in line with the results of the preceding project and the state-of-the-art European developments in the area of doctoral education
- To raise the capacity of Uzbekistan HEI's in implementing national standards for quality assurance in doctoral education.
- To increase the capacity of academic and non-academic human resources in Uzbekistan HEIs to contribute toward the implementation of the reforms of doctoral education.
- To improve the collaboration between the academic and business sector and industry in Uzbekistan, reducing the skills gap between doctorate holders and the business sector.

# Quality assurance activities of the project

- Quality assurance plan developed by ELTE approved by the steering committee
- The QA plan covers: necessary monitoring steps, feedback loops, and activities during the project life
- Evaluation and quality control elements used in the project :

  - Evaluations forms for workshops;
  - Reports from the job shadowing events;
  - Internal feedback during six consortium meetings and the ULCB meetings;
  - External expert evaluation report;





### Sustainability issues

- trainings of academic staff, administrative personnel and doctoral candidates are expected to continue in some form with the financial backing of Uzbek HEIs and the Ministry; skills taught during the trainings will add to the sustainability of the project
- job shadowing will create opportunities for Uzbek colleagues to link with European partners and to establish contacts and networks which can be further maintained and broaden once the project ends.
- quality assurance standards developed during the prior project will be included in the exercise to create a model of a new joint doctoral programme,
- the new mechanism of quality assurance will enhance their ability to modernize their doctoral education.
