- Composition of the team junior, senior, external
- External expertise
- Clarity of the text
- Multiple effect various levels of education
- "work" with the students pregraduate, postgraduate
- Impact: "large number" of students?
- Activities also in English?
- Enough time to prepare the application
- Patience and endurance
